

Update on Phase II Projects

## **New Band Room**

The new band room will be an exciting 3,200 sq. ft. addition to the exterior of the current Fine Arts Center. Designed with both efficiency and function in mind, this space will incorporate three existing walls—making it a cost-effective solution while keeping it conveniently connected to our Fine Arts center. Once complete, the new addition will offer improved acoustics, enhanced safety, and modern amenities to support our students and the continued growth of our band program.



## Former Pool to Become a "Fieldhouse"

With the band room relocating, the former pool area will be transformed into a versatile indoor athletic space. This new "fieldhouse" will serve as a multi-use training facility, accessible to all athletic programs and designed to support year-round conditioning and practice needs.

## Industrial Education Upgrades

Another key component of our Phase II projects involves updating the Woodworking, CAD, and Metal labs, as well as creating a dedicated workspace for our high school Robotics team. After thoughtful discussions with key stakeholders, we developed a design focused on adaptability, ensuring these spaces can evolve with changing student needs and program growth. These upgrades will further promote hands-on, project-based learning, giving students real-world experience in engineering, design, and skilled trades.

Please remember the following tips when picking up your child(ren) from Baker Elementary:

- 1. You will be given two nameplates at Open House on August 19. Hang one of your name plates on the rearview mirror of your vehicle. We cannot put a student in the car without a name plate, and will ask that you pull around to our main office if you do not have one.
- 2. Drive in a single-file line around the west parking lot.
- 3. Practice opening the car door, getting in the car, closing the door and buckling at home. For maximum safety, students can only enter the car on the side closest to the sidewalk. Please move car seats ahead of time if this is a barrier.





## Drop-Off/Pick-Up Info:

We're excited to share new procedures for student drop-off and pickup at Steeby Elementary, designed to improve safety and ease congestion during these busy times. Please take a moment to review the updated guidelines:

- Drivers should enter from the E. Maple Street entrance at the back of Steeby and turn south onto the service drive along the west side of the building.
- The line will begin at the yellow gate, which will remain closed until school aides open it to start the pickup and drop-off process.
- Once the gate is open, drivers will follow the loop and cones, passing the visitor parking around the outside of the lot and then heading once again through the service drive out to E. Maple Street.
- Vehicles will not be permitted to enter the parking lot near Superior Street to join the line.

For everyone's safety, please remain in your vehicles at all times—do not exit your car to walk students to or from the doors. This will help keep the process moving smoothly and safely.

This change is aimed at reducing traffic backups on E. Maple, eliminating the risk of vehicles moving into oncoming traffic, and creating a safer, more efficient flow of cars during pick-up and drop-off.



## Public Notices

#### **Pesticides Control Act**

Wayland Union Schools has adopted an Integrated Pest Management program. Inherent with this are the Wayland Union School's efforts to reduce pesticide use as much as possible. While it may occasionally be necessary to apply a pesticide, this program does not rely on routine pesticide applications to resolve problems. We use various techniques such as habitat alteration, sanitation, mechanical means, exclusion, etc. to prevent pest from becoming a problem.

As required by Michigan law, you will receive advanced notice of non-emergency application of a pesticide (insecticide, fungicide, or herbicide), other than bait or gel formulation, which is made to the school, school grounds, or buildings. This advance notice of a pesticide application will be given 48 hours before the application by the following two methods:

- 1) Posting at the primary entrances to your child's school. The entrances that will be posted are the main entrance and those that have a sidewalk that leads directly to a parking lot.
- 2) Posting in the common area located by the main office of the school.

Please note that notification is not given for use of sanitizers, germicides, disinfectants or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without prior notice to prevent injury to students, but you will be promptly notified following any such application, via the two posting methods identified (above).

You may review the school's Integrated Pest Management program and records of any pesticide application upon request by contacting John Huyck, Maintenance Supervisor, huyckj@waylandunion.org.

Parents or guardians of children attending the school are also entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked at least 3 days before the application, if they so request. If you would like to be notified by mail please contact John Huyck, Maintenance Supervisor at huyckj@waylandunion.org. Please give, your name, mailing address and what school(s) your child or children attend and they will put your name on the advance notification by US Mail list.

#### **Dangerous Weapons Policy**

The Board of Education prohibits students from possessing, storing, making, or using a weapon in any setting that is under the control and supervision of the District for the purpose of school activities approved and authorized by the District including, but not limited to, property leased, owned, or contracted for by the District, a school-sponsored event, or in a District vehicle without the permission of the Superintendent. The term "weapon" means any object which, in the manner in which it is used, is intended to be used, or represented, is capable of inflicting serious bodily harm or property damage, as well as endangering the health and safety of persons. Weapons include, but are not limited to, firearms, guns of any type whatsoever, including air and gas-powered guns (whether loaded or unloaded), knives, razors, clubs, electric weapons, metallic knuckles, martial arts weapons, ammunition, and explosives. This policy shall also encompass such actions as look-alike items, false fire alarms, bomb threats, or intentional calls to falsely report a dangerous condition. The Superintendent is authorized to establish instructional programs on weapons, which require students to immediately report knowledge of weapons and threats of violence by students and staff to the building principal. Failure to report such knowledge may subject the student to discipline up to and including suspension or expulsion from school. The Superintendent will refer any student who violates this policy to the student's parents or guardians and to the criminal justice or juvenile delinquency system. The student may also be subject to disciplinary action, up to and including expulsion. Policy exceptions include:

A. weapons under the control of law enforcement personnel;

B. items pre-approved by the building principal as part of a class or individual presentation under adult supervision, if used for the purpose and in the manner approved; (working firearms and any ammunition will never be approved as part of a presentation.)

C. theatrical props used in appropriate settings.

#### Title IX pf the Education Amendments of 1972

A person who believes he or she has been or is the victim of sexual harassment should immediately report the situation to the building principal or assistant principal, the Superintendent, or a Title IX Coordinator. A District employee who observes, has knowledge of, or learns that a person has been or is the victim of sexual harassment shall immediately report the situation to the building principal or assistant principal, Superintendent or Title IX Coordinator. Complaints against the building principal should be filed with the Superintendent or Title IX Coordinator. Complaints against the Superintendent should be filed with the Board President or Title IX Coordinator. Please contact Wayland Union Schools Administration, 850 E. Superior St., Wayland MI 49348. #### Student Privacy and Parental Access to Information

The Board of Education respects the privacy rights of parents and their children. No student shall be required as part of the school program or the District's curriculum, without prior written consent of the student, (if an adult or an emancipated minor) or, of an unemancipated minor, his/her parents, to submit to or participate in any survey, analysis, or evaluation that reveals information concerning:

- A. Political affiliations or beliefs of the student or his/her parents;
- B. Mental or psychological problems of the student or his/her family;
- C. Sex behavior or attitudes;
- D. Illegal, anti-social, self-incriminating or demeaning behavior;
- E. Critical appraisals of other individuals with whom respondents have close family relationships;
- F. Legally-recognized privileged and analogous relationships, such as those of lawyers, physicians, and ministers;
- G. Religious practices, affiliations or beliefs of the student or his/her parents; or
- H. Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such a program).

The Superintendent shall ensure that procedures are established whereby parents may inspect any materials used in conjunction with any such survey, analysis, or evaluation. Further, parents have the right to inspect, upon request, a survey or evaluation created by a third party before the survey/evaluation is administered or distributed by the school to the student. The parent will have access to the survey/evaluation within a reasonable period of time, after the request is received by the building principal.

To ensure the right of parents, the Board directs building and program administrators to: A. Notify parents in writing of any surveys, analyses, or evaluations, which may reveal any of the information, as identified in A-H above, in a timely manner, and which allows interested parties to request an opportunity to inspect the survey, analysis, or evaluation; and the administrator to arrange for inspection prior to initiating the activity with the students.

- B. Allow the parent the option of excluding their student from the activity.
- C. Report collected data in a summarized fashion, which does not permit one to make a connection between the data and individual students or small groups of students.
- D. Treat information as identified in A-H above as any other confidential information in accordance with Board of Education Policy #8350.

Additionally, parents have the right to inspect, upon request, any instructional material used as part of the educational curriculum of the

student. The parent will have access to the instructional material within a reasonable period of time after the request is received by the building principal. The term instructional material means instructional content that is provided to a student, regardless of its format, including printed and representational materials, audio-visual materials, and materials in electronic or digital formats (such as materials accessible through the Internet). The term does not include academic tests or assessments. The Board will not allow the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information (or otherwise providing that information to others for that purpose).

#### Safe and Drug Free Schools and Communities Act

Wayland Union Schools recognizes and abides by the standards of the Safe and Drug Free Schools and Communities Act and the Drug Free Workplace Act. These standards prohibit the unlawful manufacture, possession, use, sale, distribution, or concealment of illegal drugs and alcohol in school programs, school vehicles, school premises, and at school sponsored activities on and off school property. Drugs include all controlled substances as defined by law, as well as "look-alike" drugs, steroids, and alcohol. These standards apply to all Wayland Union Schools students and staff. The use/abuse of drugs and alcohol poses serious health and safety risks to Wayland Union Schools students. We urge students, parents, guardians, and care providers to work hand-in-hand with our district to ensure that these important standards are upheld.

#### Asbestos Awareness Update

In July 2024, an outside company (Delisle Associates) completed a regularly scheduled inspection of all remaining asbestos-containing materials in district facilities. This inspection, and routine six-month inspections performed by district personnel, are part of our Management Plan. Asbestos materials were confirmed in Steeby, Baker, Dorr, the Pine Street Elementary complex, Wayland Union High School, and the Administration Building. They were found to be in good condition and present no danger to students, staff or visitors. If and when any changes occur, employees and parents will be notified promptly. Parents who wish to review the district's Management Plan may do so by contacting the Director of Operations office at 269-792-2181.

## Public Notices

#### Federal Educational Rights and Privacy Act (FERPA)

In compliance with Federal regulations, Wayland Union Schools has established the following guidelines concerning student records:

- Each building principal is the Custodian for Records for their building, and is responsible for the processing and maintenance of all student records. His/her office is located at the respective schools, or can be reached by calling 269-792-2181.
- Each student's records will be kept in a confidential file located at that student's respective school building. The information in a student's record file will be available for review only by the parents or legal guardian of a student, an adult student (18 years of age or older), and those designated by Federal law or District regulations.
- If not satisfied with the accuracy of the records or with the District's compliance with the Federal Education Rights and Privacy Act, a parent, guardian, or adult student has the right to request a change or addition to a student's records, and to (a) obtain a hearing with District officials (b) file a complaint with the U.S. Department of Education.

The District has established the following information about each student as directory information, and will make it available upon a legitimate request unless a parent, guardian, or adult student notifies the Records Control Office in writing within 10 days from the date of this notification

that they will not permit distribution of any or all information:

- a. Name, address and telephone number;
- b. Date and place of birth;
- c. Photograph;
- d. Major field of study;
- e. Participation in officially recognized activities and sports;
- f. Height and weight, if a member of an athletic team;
- g. Dates of attendance, date of graduation, and awards received;
- h. Any other information the District considers would not be harmful or an invasion of privacy, if disclosed.

A copy of the Board of Education's policy and the accompanying District regulations are available at Wayland Union Schools. There will also be a person available to answer any questions concerning the policy or regulations.

#### Statement of Assurance of Compliance with Federal and State Law

The Wayland Union Schools District Board of Education complies with all Federal and State laws and regulations prohibiting discrimination, and with all requirements and regulations of the Wayland Union Schools District Board of Education. It is the policy of the Wayland Union Schools District Board of Education that no person be discriminated against on the basis of the Protected Classes of race, color, national origin, sex (including sexual orientation or transgender identity), disability, age (except as authorized by law), religion, military status, ancestry, or any other statutorily protected category (collectively, "Protected Classes") in its educational programs or activities.

#### Personal Curriculum Notice

Parents and students in grades 9-12 are being notified that all students may be eligible and entitled to a Personal Curriculum to modify the Michigan Merit Curriculum (MMC) requirements for graduation and earning a diploma. The Personal Curriculum is a process to modify specific credit requirements and/or content expectations based on individual learning needs of a student. It is designed to serve students who want to accelerate or go beyond the MMC requirements and students who need to individualize learning requirements to meet the MMC requirements. Personal Curriculum modifications must align with the High School Content Expectations (HSCE) as practicable and must not create barriers that limit a student's opportunity to be engaged in a challenging curriculum. #### No Smoking

In order to protect students and employees who choose not to use tobacco products from an environment noxious to them and potentially damaging to their health, the Board prohibits the use of tobacco products and all electric smoking devices on District premises (owned or leased), in District vehicles, at all school-sponsored events, and in all school buildings owned and/or operated by the District. Please read board policy 7434 for the full statement.

#### Section 504 Protects Children from Discrimination

Section 504 is an Act which prohibits discrimination against persons with a handicap in any program receiving Federal financial assistance. The Act defines a person with a handicap as anyone who:

- 1. has a mental or physical impairment which substantially limits one or more major life activities (major life activities include activities such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning and working);
- 2. has a record of such an impairment; or
- 3. is regarded as having such an impairment.

In order to fulfill this obligation under Section 504, the Wayland Union School District recognizes a responsibility to avoid discrimination in policies and practices regarding its personnel and students. No

discrimination against any person with a handicap will knowingly be permitted in any of the programs and practices in the school system.

The school district has specific responsibilities under the Act, which include the responsibility to identify, evaluate, and if the child is determined to be eligible under Section 504, to afford access to appropriate educational services. If the parent or guardian disagrees with the determination made by the professional staff of the school district, he/she has a right to a hearing with an impartial hearing officer. #### Homeless Students

Children who are identified as meeting the Federal definition of "homeless" will be provided a free appropriate public education (FAPE) in the same manner as all other students of the District. To that end, homeless students will not be stigmatized or segregated on the basis of their status as homeless. The District shall establish safeguards that protect homeless students from discrimination on the basis of their homelessness. #### Website Accessibility

The District is committed to providing person with disabilities an opportunity equal to that of persons without disabilities to participate in the District's programs, benefits, and services, including those delivered through electronic and information technology, except where doing so would impose an undue burden or create a fundamental alteration. The District is further committed to ensuring persons with disabilities are able to acquire the same information, engage in the same interactions, and enjoy the same benefits and services within the same timeframe as persons without a disability, with substantially equivalent ease of use; and they are not excluded from participation in, denied the benefits of, or otherwise subjected to discrimination in any District programs, services, and activities delivered online, as required by Section 504 and Title II of the ADA and their implementing regulations; and that they receive effective communication of the District's programs, services and activities delivered online.

#### Use of Medications

The Board of Education shall not be responsible for the diagnosis and treatment of student illness. The administration of prescribed medication and/or medically-prescribed treatments to a student during school hours will be permitted only when failure to do so would jeopardize the health of the student, the student would not be able to attend school if the medication or treatment were not made available during school hours, or the student is disabled and requires medication to benefit from the student's educational program.

Before any prescribed medication may be administered to any student during school hours, the Board shall require the written instructions from the child's practitioner, accompanied by the written authorization of the parent. Such documentation shall be kept on file in the school office. Prescription medication must be provided in the original container with the prescription label showing the name and telephone number of the pharmacy, the student's name, the name of the physician, the name of the drug, and the dosage to be administered.
