Section 31aa

Provides per pupil funding to public districts and Intermediate School Districts (ISDs) for activities to improve student mental health.

The allowable expenditures of funds include the following:

- Hiring or contracting for support staff for student mental health needs, including, but not limited to, school psychologists, social workers, counselors, and school nurses
- Purchasing and implementing mental health screening tools
- Providing school-based mental health personnel access to consultation with behavioral health clinicians to respond to complex student mental health needs (MC3)
- Any other mental health services or product necessary to improve or maintain the mental health of students and staff

2. Applicants must use community input to guide the expenditure of the funds and shall pledge to host at least 1 community conversation about student mental health and school safety.

Section 310

- > Funding to ISDs and public districts for direct service providers (nurses, social workers, psychologists, counselors) with 100% in year 1, 66% in year 2, 33% in year 3
- Reminder: School Aid Budget Section 310 Reporting The Michigan Department of Education's Office of Health and Nutrition Services is requesting that districts who hired Section 310 providers between July 1, 2022, and March 1, 2022, and received 310 funds in Year 1 (Fiscal Year 2022), report retention of those hires through GEMS/MARS accessed in the MiLogin for Third Party portal by 11:59 p.m. Sunday, October 23, 2022, to receive the 66% funding in Year 2 (Fiscal Year 2023). The portal will open on Monday, September 26, 2022. [MDE Memo 9.15]

Section 97

Per pupil funding calculation

Allowable expenditures of funds allocated under this section include:

- 1. Coordination with local law enforcement.
- 2. Training for school staff on threat assessment.
- 3. Training for school staff and students on threat response.
- 4. Training for school staff on crisis communication.
- 5. Safety infrastructure, including, but not limited to, cameras, door blocks, hardened vestibules, window screening, and technology necessary to operate buzzer systems. This may also include firearm detection software that integrates to existing security cameras to detect and alert school personnel and first responders to visible firearms on school property. The software described in the immediately preceding sentence must be organically developed and proprietary to the company it is purchased from and should not include any third-party or open-source data.
- 6. Age-appropriate training for students and families on responsible gun ownership.
- 7. Providing professional development to school resource officers that includes training on the best practices for serving in a school setting.
- 8. Any other school safety service or product necessary to improve or maintain security

Section 97c

Up to \$2,000 for each school building to contract with a vendor for the completion of comprehensive safety and security assessments

- 1. Has a well-developed process for assessing safety and security in schools including: An assessment of physical security, policies, and procedures related to school safety and security A method for assessment of the process
- 2. Provides actionable recommendations that are documented
- 3. Provides a description of the process, including costs
- 4. Has a history of assessing K to 12 schools

- 5. Can provide examples of findings reports with comprehensive reviews of all elements of safety and security that include reviews of board policies, emergency operations plans, environment, exterior and interior, policy and procedures, and training and equipment
- 6. Can provide ongoing assistance, including, but not limited to, board presentations, community presentations, and consulting, to assist in the implementation of any recommendations made in any findings reports and the fees associated
- 7. Can provide basic qualifications for any assessors that will complete assessments, including, but not limited to Education, Work history, Experience in assessing K to 12 schools
- 8. If contracting with subcontractors, ensures that the subcontractors have experience in safety and security or law enforcement for the provision of services
- 9. If contracting with subcontractors, ensures that the subcontractors have familiarity with MDE's school safety guidelines
- 10. Has experience in assessing safety and security in programs and facilities used outside of the school day, including, but not limited to, athletic facilities and programs
- 11. Has experience in assessing safety and security in facilities and programs with specialized needs, including, but not limited to, early-childhood-education facilities, special-needs facilities, community-education programs, and adult- education programs
- 12. Operates in the best interest of the district without any external vendor influence
- 13. Does not do any of the following: 1) Represent companies that sell safety and security products, 2) Accept referral fees for recommending products, and/or 3) Accept or solicit referral fees, or operate on behalf of, any equipment or technology vendors.

Section 97d

Critical incident mapping uses satellite imaging to create a real-life depiction of a building with labels for important areas like the cafeteria or gymnasium. A grid is placed over the map to help first responders communicate more accurately. The critical incidence mapping:

- 1. Must be compatible with platforms and applications used by local, state, and federal public safety officials.
- 2. Must not require the purchase of additional software for use.
- 3. Must be provided in a printable format.
- 4. Must be verified for accuracy through a walk-through of a school building and school grounds.
- 5. Must be oriented true north.
- 6. Must include accurate floor plans overlaid on or current aerial imagery of a school building or school plan.
- 7. Must include site-specific labeling that matches the structure of the school building, including room labels, hallway names, external door or stairwell numbers, locations of hazards, key utility locations, key boxes, automated external defibrillators, and trauma kits.
- 8. Must include site-specific labeling that matches the school grounds, including parking areas, athletic fields, surrounding roads, and neighboring properties.
- 9. Must include a gridded overlay with x/y coordinates.
- 10. Must include information that best assists first responders in an emergency, including, but not limited to, the following information: Building numbers, Floors, Suite designations, Room numbers, Other available relevant location information for each school.
