### **YOUR RIGHTS**

Every person who receives publicly funded mental health services in Michigan is afforded specific rights that are identified in the Michigan Mental Health Code. This law governs the delivery of public mental health and developmental disability services in Michigan. Some of your rights include:

- The right to be free from abuse and neglect
- The right to confidentiality (privacy)
- The right to be treated with dignity and respect
- The right to services that meet your needs

You have many other rights specific to your mental health services. More information about your rights is contained in "Your Rights When Receiving Mental Health Services in Michigan", which is provided and explained when services begin, and annually. You may request this booklet, or ask questions about your rights at any time.
